The 2nd Meeting of the State Level Start-up Council for the **Sector Agnostic Tripura Start-up Policy** was convened under the chairmanship of the Secretary, IT, on 24th and 25th July 2025. 

III. Approval for reimbursement to Start-Ups for participation in national events: A few registered Start-ups from Tripura had participated in two national level events held at Bharat Mandapam, New Delhi. The **first event** was Start-Up Mahakumbh held during 3rd April to 5th April 2025 were attended by 2 (two) Start-Ups namely **HN Technologies** and **RNJ Agriclinc and Agribusiness Pvt. Ltd.** The **second event** was Rising NE Investors Summit 2025 was held during 23rd May to 24th May 2025 were attended by 5 (five) Start-Ups. They are as: **RNJ Agriclinc and Agribusiness Pvt. Ltd., iLogitron Technologies Pvt. Ltd., D&D Learning Pvt. Ltd., Salphan Energy Pvt. Ltd. and Kiwis Media Technologies Pvt. Ltd.**


The Council recommended reimbursement to the above-mentioned registered Start-ups from Tripura for their participation in these national-level events, in accordance with the provisions of the Tripura Start-up Policy.

After detailed discussions, the Council recommended for considering the approval of Proof of Concept (PoC) of Kiwis Media Technologies Pvt. Ltd and recommended for considering for Recognition of the 18 (Eighteen) startups: (1) KYMA AI Innovations (OPC) Pvt. Ltd. (2) Niljyoti Mobility (3) ORARIDE Global Technologies Pvt. 
With regard to the following 8 (Eight) startups (1) DATSERA Solutions Pvt. Ltd. (2) ADMITEASE (3) Prem Barua Pvt. Ltd. (4) Start-Up Dekho (5) Debnath Solutions Pvt. Ltd. (6) Patron Consultancy Services (7) Ethnobyte Global LLP (8) Skillentia — the Council observed certain gaps in their current level of preparedness. Accordingly, it was advised that these startups revisit and refine their proposals, and present their revised ideas at the next Council meeting with improved clarity and readiness. In addition, ANT Equipment Rentals was unable to present its proposal due to unforeseen technical issues. the Council suggested that ANT Equipment Rentals be given the opportunity to present its proposal in the next meeting. 



Sl. No.	Name of the Start-up	Observations of the State Level Start-up Council in the meeting held on 24 th and 25 th July, 2025
1	DATSER Solutions Pvt. Ltd	Better clarity on sustainability of the initiative is required and suggested for market analysis for further progress is suggested. The Council directed the startup to revise its plan and re-present in any future Council Meeting.
2	ADMITEASE	The proposal shown during the council meeting is not clearly defined and scope of work of the proposal is not sustainable in its current form. The Council directed the startup to revise its plan and re-present in any future Council Meeting.
3	Prem Barua Pvt. Ltd.	The council observed that the proposal has some potential but they do not have clarity on supply chain of their products, business module of the products etc. The Council directed the startup to revise its plan and re-present in any future Council Meeting.
4	Start-Up Dekho	The proposal requires more clarity on business proposal such as the kind of services the Start-Up wants to provide and the way to provide such kind of services. The Council directed the startup to revise its plan and re-present in future Council Meeting.
5	Debnath Solutions Pvt. Ltd.	The council observed that the services suggested by the Start-Up is only for School Education Department, Govt. of Tripura. In such scenarios, the council requested the Start-Up with their proposal to the concerned department as the services proposed may not be related to Start-Up activities.
6	Patron Consultancy Services	The proposal shown by the Start-Up requires more clarity about their service offerings. The Council directed the startup to revise its plan and re-present in any future Council Meeting.
7	Ethnobyte Global LLP	The council has suggested to prepare a more realistic business proposal and to appear again for council meeting after revising the proposal in near future.
8	Skillentia	The council has observed that the Start-Up need to get requisite certificates for the operational need and more clarity on their business process. The Council directed the startup to revise its plan and re-present in any future Council Meeting
